*From January 1, 2014, Pakistan became eligible for an EU trade programme known as GSP+ which would allow almost all of Pakistan's exports to enter the EU free of duty. This document is intended to explain in general terms what the facility means and how best to make use of it.*

## What is GSP+?

The Generalized System of Preferences, also known as GSP+, is a trade program of the European Union (EU) which allows duty free (or at preferential duty) access to certain designated developing countries. Pakistan became a beneficiary of this scheme as of January 1, 2014.

## What benefits will it bring for Pakistani exporters?

Pakistan can now export some 6,000 tariff lines including textiles and clothing, free of duty to the European Union's 27 member countries. Historically, Pakistan has had difficulty competing in the EU market because competitors such as Bangladesh, Sri Lanka, Turkey, Morocco, Tunisia and Mexico already enjoyed duty free access. GSP+ will also provide Pakistan's industries with an edge compared to countries such as China, which does not have duty free access to the EU, and India, which has only limited concessions for apparels under the standard GSP.

## What are the expected gains in terms of increased exports?

According to an International Trade Commission (ITC) report, gains from increased exports are estimated at around USD \$580 million (approximately USD \$280 million in textiles, USD \$97 million in leather articles, and USD \$203 million for all other products). This estimate by the ITC is modest compared with others that have projected gains in the range of USD \$1-2 billion.

### What are the major products now being exported to the EU, and what tariff reductions will be received?

Pakistan's total exports to the EU during the 2012 calendar year amounted to USD \$5.6 billion, of which the following products accounted for USD \$4.57 billion, or 82%.

### What about Pakistan's other major exports such as rice, sports goods, and surgical instruments?

Sports goods and surgical instruments already enjoy duty free access to the EU, as their normal tariff is zero. In case of rice, husked Basmati rice which is generally exported from Pakistan is duty free.

### What products can benefit from increased exportation to the EU?

There are a large number of goods produced in Pakistan that stand to benefit from GSP+. Among those that have the highest potential for increased exportation are fruit juices, prepared or preserved vegetables and fruits, woven and knitted garments, bed linen, carpets, fabrics, gloves, and confectionary. A list of the EU's top 2000 product imports from Pakistan is provided in Appendix B. The table includes Pakistan's share of the EU market for each of these items, their GSP versus Most Favored Nation (MFN) tariff, and the potential level of exports.

### What is the total percentage of Pakistan's products that are expected to enjoy duty free access?

More than 90% of Pakistan's exports to the EU will be eligible for duty free access.

### How does GSP+ differ from the standard GSP, which was previously available to Pakistan?

GSP + differs from the standard GSP in the following respects:

1. Under the standard GSP, there was a nominal difference between GSP and MFN tariffs on certain products. For example, clothing had a tariff of 9.6% under GSP, and 12% under MFN, a difference of 2.4%. Thus many importers did not bother to claim this concession because of the cost of meeting additional documentation. Under GSP+, the tariff rate will become zero, compared with 12% if no concession was available.
2. The GSP+ scheme offer duty free access for “sensitive” items such as textiles and clothing.
3. Under the standard GSP, if the average imports of a section from a given country exceed 17% of GSP imports of the same products from all GSP beneficiary countries over a period of three consecutive years (the trigger is 14.5% for textiles and clothing), the product is graduated. This does not apply to GSP + countries.
4. GSP+ will last for 10 years, compared with the three year duration of GSP.

### **Is there a list which shows which countries and which products are graduated?**

Yes, the EU has published a list of graduated sectors for the period January 1, 2014 – December 31, 2016 for its GSP schemes. This list shows that China is already graduated for GSP concessions for 12 sections, including textiles and clothing. India is graduated for textiles and some other products.

### **Would the GSP+ preferential access be withdrawn if there are big surges in exports from Pakistan?**

If the GSP-covered imports exceed 2% of the EU's imports from all GSP beneficiaries (Pakistan's share of total GSP imports is 1.6%), it could lose GSP+ status when the scheme is reviewed after 3 years. Furthermore, the EU regulations on safeguard in the textile, agriculture and fisheries sector provide that on 1 January of each year, the European Commission can remove the tariff preferences for products whose imports increase by at least 13.5% in quantity (by volume) as compared with the previous calendar year. However, these provisions only apply for those products whose share exceeds 6% of total EU imports in value.

### **What are the criteria for GSP+ eligibility?**

The coverage of GSP+ is restricted to those countries which are considered to be vulnerable due to a lack of diversification and insufficient integration into the international trading system. These countries have to meet the following two criteria:

- i. GSP-covered imports should represent less than 2% of the EU's imports from all GSP beneficiaries (Pakistan's share of total GSP imports is 1.6%).
- ii. The seven largest GSP-covered product sections must cover at least 75% of the country's total GSP-covered exports to the EU (Pakistan's seven largest GSP sections account for 94.6% of its total GSP-covered exports).

Even if a developing country meets the above criteria, however, its entry into GSP+ is not automatic. The country must also demonstrate that it has ratified and implemented 27 core international conventions on human and labor rights, sustainable development, and good governance (see below).

### **Were there any conditions for becoming eligible for GSP+?**

In addition to the vulnerability criteria discussed above, Pakistan had to ratify 27 core international conventions and subscribe to binding commitments to implement them effectively. These are mainly UN

and International Labour Organization (ILO) conventions and conventions on the environment and good governance. Examples of such conventions are: the Convention on the Elimination of all Forms of Racial Discrimination, the International Convention on the Rights of the Child, the Freedom of Association and Protection of the Right to Organize Convention, and the Convention on International Trade in Endangered Species. Appendix A contains a complete list of the required conventions.

#### **Are there any other EU schemes which allow duty free access to the EU?**

Yes, there are additional schemes that allow duty free access to the EU. In fact, the EU's "Everything but Arms" scheme provides more concessions than GSP+, as it allows duty and quota free access for all goods except arms and ammunitions. Under this scheme there is no graduation and no requirement to accede to certain conventions, but this scheme is only available to Least Developed Countries (LDCs), the majority of which are located in Africa (34 out of 49). The LDCs in the Asian region are Bangladesh, Afghanistan, Myanmar, Nepal, Bhutan and the Maldives.

#### **How will the compliance of international conventions be monitored under GSP+?**

The Government of Pakistan (GoP) has signed a 'binding undertaking' committing itself to maintaining the ratification of the 27 relevant international conventions and ensuring their effective implementation. It has also accepted, without reservation, reporting requirements and monitoring mechanisms imposed by those conventions. Finally, the GoP is committed to accepting and cooperating with the EU monitoring procedure. The EU is in the process of giving Pakistan a scorecard, which will form the basis for dialogue on GSP+ compliance.

#### **Who will monitor compliance with the Conventions?**

The UN/International Labour Organization reporting systems are operational, but the EU will not limit itself to these sources. It may use information from civil society organizations and social partners that are judged to be accurate and reliable reporting sources. Detailed procedural rules have been drawn up regarding the specific roles for all contributing parties: European Commission, EU Member States, beneficiary country concerned, third parties, etc.

#### **How frequently will the EU report on compliance?**

The EU will report on compliance every two years, with the first report issued by January 1, 2016. The report will cover the status of ratification of the relevant conventions, the compliance of the GSP+ beneficiary countries with any reporting obligations under those conventions, and the status of the effective implementation thereof.

#### **Have GSP concessions been withdrawn from any beneficiary country because of violations of any of the required conventions?**

Yes, it was done for Sri Lanka in 2010 due to non-effective implementation of certain human rights conventions. GSP concessions were also withdrawn from Belarus and Myanmar on the grounds of serious and systematic violation of labour rights.

#### **Can Pakistan lose the GSP+ status if it is found that it is not meeting its commitments?**

Yes, the GSP+ preferences can be withdrawn partially or fully if the GoP fails to meet its commitments on enforcing the required conventions. The burden of proof for compliance rests on the GoP. If, after investigation, the EU is convinced that the binding commitments are not met, it can temporarily withdraw the GSP+ concessions.

#### **What is the procedure for withdrawal of GSP + concessions?**

If the European Commission has a reasonable doubt that a particular GSP+ beneficiary country does not respect its binding undertakings, it can initiate the procedure for the temporary withdrawal of tariff preferences. This involves publishing a notice and notifying the GSP+ beneficiary country of the grounds for which the concessions are being withdrawn. The beneficiary country is given up to six months to submit its observations. If the Commission considers that the findings justify temporary withdrawal, it can do so six months after its decision.

#### **Are there any reasons other than violations of the conventions for which GSP + tariff preferences can be withdrawn?**

Yes, GSP+ can be withdrawn for the following reasons:

- a) Export of goods made by prison labor
- b) Serious shortcomings in customs controls on the export or transit of drugs
- c) Failure to comply with international conventions on anti-terrorism and money laundering
- d) Serious and systematic unfair trading practices based on a previous determination to that effect by the competent WTO body
- e) Serious and systematic infringement concerning the conservation and management of fishery resources
- f) Any irregularities or systematic failure to comply with the rules concerning the origin of the products and failure to provide administrative cooperation as required for the implementation and policing of the preferential arrangements

#### **If a product is subject to an anti-dumping or anti-subsidies duty, can trade preferences be withdrawn for such products?**

No, the preferential arrangements will not be withdrawn for such cases.

#### **What are the key steps that Pakistan's industry and government should take to make maximum use of this facility?**

There are five key steps that will maximize the benefits of GSP+:

- i. The GoP should carry out tariff reforms so that Pakistan's industries can source cheaper raw materials, rather than having to pay duties and then claim refunds;
- ii. Any tax or rebate incentives should only be permitted for value-added products, and not for the export of non-value goods such as yarn or grey fabrics;
- iii. The GoP should immediately allow the import of all goods from India so that Pakistan's local industries can add value and re-export these goods;

- iv. The GoP should require customs and other agencies involved in export to adopt the latest trade facilitation practices, which will cut the cost of exports; and
- v. The GoP should ensure that necessary inputs, such as gas and electricity, are available on a regular and reliable basis, so that industries can operate at maximum capacity.

#### **Could the GSP+ scheme be challenged in the WTO (similar to India's challenge in 2001 when the EU allowed duty free imports to Pakistan under the "Drugs Arrangement")?**

Yes, the scheme can be challenged at the WTO; however, it should be noted that in the Drugs Arrangement case, the WTO ruled that preferential access is permitted, provided it is made available on the basis of an objective standard. In the case of GSP+, the EU has devised a vulnerability standard, and therefore the scheme appears to be compliant with WTO rules.

#### **How can Pakistan ensure that GSP+ provides a reasonable time to establish its market and justify any investment for this purpose?**

The GSP+ scheme is valid for 10 years; however, it can be withdrawn earlier for any of the following reasons:

- i. If Pakistan is found to be seriously and systematically violating core principles of the 27 international conventions that it has already ratified
- ii. If there are serious shortcomings in customs controls on exports to the EU
- iii. If Pakistan's share of exports to the EU exceeds 2% in value of the EU's imports from all GSP beneficiaries

Therefore it is imperative that Pakistan establishes a mechanism to ensure that there is no lapse in the implementation of the 27 core conventions. In addition, Pakistan must monitor the performance of customs regarding the flow of illicit substances, as well as the potential that other countries' goods will be rerouted for export from Pakistan in order to claim the benefit of the GSP+ scheme.

Pakistan's current share of the EU's GSP imports is 1.6%; there is a risk that the 2% threshold will be passed. Pakistan should begin lobbying the EU to raise this limit to 5%.

#### **Are there any downsides to GSP + concessions?**

Yes, there are some downsides to GSP+ concessions. First, it is a unilateral concession and can be withdrawn if the EU is not satisfied with the implementation of any of the conditions for which it was granted. It is unlike the concessions which Turkey, Mexico and many other countries have under FTAs, or the concessions Bangladesh, Nepal, and Afghanistan have because of their LDC status. Second, Pakistan's export basket, which is already quite restricted, may become even more so as many exporters would like to benefit from tax concessions and focus on those items on which the EU has a high duty. Third, if Pakistan's share of exports to the EU exceeds 2% in value of the EU's imports from all GSP beneficiaries, it could become ineligible for GSP + concessions. There is a strong likelihood this will

happen, as Pakistan's current share in the EU is 1.6%. Finally, the granting of GSP+ may create complacency on the part of Pakistan, and act as a disincentive to efforts to negotiate a FTA with the EU, which would be a more permanent mechanism for enjoying duty free access.

#### **Who else enjoys GSP+ concessions?**

In addition to Pakistan, this scheme is available to nine countries: Armenia, Bolivia, Cape Verde, Costa Rica, Ecuador, Georgia, Mongolia, Paraguay and Peru.
